Lodging FIR against offender.

- Rigorous Imprisonment for up to 3 years (under court of law).
- Fine up to Rs. 2,50,000/- (up to Rs. 2.5 Lac)
- Rustication from the institute for varying periods.
- Expulsion from the institution and consequent debarring from admission to any other institution.
- Cancellation of Admission
- Suspension from attending classes.
- Withholding / withdrawing of scholarship / fellowship and other benefits.
- Debarring from appearing for any test / examination/placement activities organized by the institute.
- Withholding of results.
- Debarring from representing the institution in any National or International meet, tournament and festival.
- Suspension / Expulsion from the hostel.

Finally, you are requested to counsel your ward not to indulge in ragging in any form. The enclosed Performa for undertakings by you and your ward may please be completed & signed as the same is required to be submitted to the department before his/her registration.
