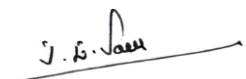

## **Guidelines for Summer Term Registration** **Attention: (Except All Pharmacy and Ph.D programmes)**

The online registration for Summer Term Classes and Examinations, 2022-23 will be open **from 3<sup>rd</sup> to 5<sup>th</sup> June 2023**. The students are advised to read carefully and follow the guidelines given below:

**A. Eligibility for Summer Term Registration:**

- 1. All Students of 2<sup>nd</sup> Year onwards of all Programmes.**
- 2. Students of 2<sup>nd</sup> Year onwards of all Programmes who have availed Semester/Year Break with prior permission.**
- 3. Students falling under N+2 Years of their Programmes.**

**B. Subjects / Courses which students can register for the Summer Term:**

1. Debarred Subjects/Courses –If the student has been debarred from appearing in the examination of a Subject /Course due to shortfall of required percentage (75%).
2. Non-Complete Subject/Courses due to semester / year break.
3. Subjects/Courses in which the student has obtained E or F grade (D, E or F grade in case of B.Arch programme).
4. Students can register Backlog/Debarred/Non-Complete Subjects/Courses of both ODD and EVEN semesters.

**C. Registration will be “With Class” only @Rs. 3000/- per course.**

**D. Students can register for the Subjects/Courses to the extent of total 4 courses or 16 credits (Whichever is maximum) only.**

**E. The credit/non credit subjects (for ex: Seminar, Aptitude Building, Soft Skill Training, Value Added Training, Comprehensive Viva Voce, Summer Training Report Presentation etc.) shall also be offered during Summer Term. These subjects will be over and above of total limit of Subjects/Credits (No fee shall be charged for such subjects).**

**F. The classes for the Summer Term will be conducted from 6<sup>th</sup> June 2023 onwards. For detailed time-table, get in touch with your respective HoD/School.**

**G. Registration Process:**

The registration on ERP for Summer Term-2022-23 will be done from back-end. Student should submit their request for Summer Term Registration through MS Form. Link for the same is provided on the 1<sup>st</sup> page of this communication.

- Students are advised to provide the details on MS Form only for Backlog Subjects/Courses (Do not choose pass Courses). Also, in case of Backlog in a course having practical component, students need to choose practical component alongwith theory course as well. Students must choose only those courses in which they have obtained ‘F’ grade.
- Once registration is done, a non-refundable amount of Rs. 3,000/- per course will be visible later on Academia ERP portal of student.
- **Only for pass-out batch students till 2017:** Account detail for payment of back paper registration fee to such students will be provided on their outlook email account.
- No request for late registration will be entertained after the last date.
