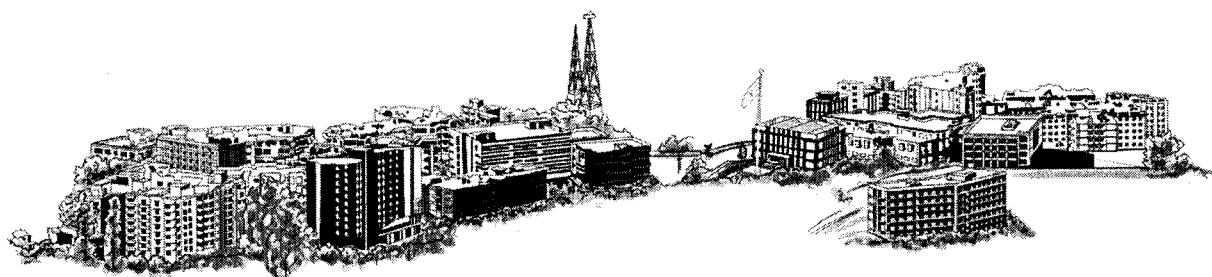

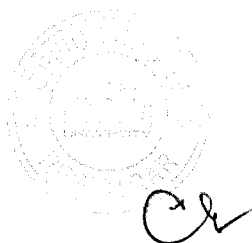

Item No.	Brief Discussion on BOS held on 10.03.2022	Action Taken
1	Item No. 10.4: To deliberate on the revised syllabus of Applied Engineering Chemistry (CHF102) for B.Tech students as per the FFCBCS.	After due deliberations and discussions board approved the revised syllabus and it was suggested to implement the same from Even Sem. Academic Year 2021-22. It was also suggested that both Engineering Chemistry (CHF101) and Applied Engineering Chemistry (CHF102) should be offered to all Engineering Undergraduates irrespective of their branch as per FFCBCS.


