

# SCHOLARSHIP POLICY (2026-27)

DIT University always encourages scholarly aptitude and merit in students. In order to facilitate scholarship among students towards their academic excellence, following scholarships are awarded by the University to Meritorious students:

## (A) MERIT BASED SCHOLARSHIP

### Applicable to: UG Programmes

#### 1. For First Year

Merit Scholarship shall be awarded on the basis of percentage of marks obtained in identified subjects at the time of admission and is applicable on the Tuition fee only. Details are given in **Annexure-1**.

#### 2. For Subsequent/Continuing Years

Based on the CGPA obtained after each completed year of study, top 10% of the students in each UG programme shall be eligible for merit scholarship applicable on the Tuition fee of respective year of study as per the following details:

- a. Scholarship will be awarded to the top 10% of total students who appeared in final term examination.
- b. Scholarship will be awarded to the students' subject to clearing all papers in single attempt without any back paper, UFM and Indiscipline case.
- c. A merit-based scholarship will not be applicable or awarded if the student has passed any courses through repeat attempts during the preceding semesters or trimesters.
- d. Merit Scholarship is applicable only if the student is not falling under academic progression and counselling board (APCB) with any of the category such as (a) or (b) or (c) or any combination of (abc) as above.
- e. Continuous Merit Scholarship shall be discontinued if the student has availed semester/year break/re-admission. Further he/she will not be eligible for any merit Scholarship throughout the program.
- f. Continuing Merit Scholarship will be granted in the Even/Odd Semester/Trimester of succeeding session. Scholarships will be awarded only if the results are available prior to registration; if not, it will be awarded in next semester.

### Scholarship Matrix

To continue the above scholarship, the student should have maintained a CGPA of 6 and above every year, without any back paper, UFM and Indiscipline case.

(applicable to top 10% students in each programme)

## **(B) UTTARAKHAND / OTHER HIMALAYAN STATES SCHOLARSHIP**

### **Applicable to: UG & PG Programmes**

25% scholarship on Tuition fee shall be granted to permanent residents of Uttarakhand / Other Himalayan States for whom 25% seats are reserved in all UG / PG programmes as per statutory requirements.

For claiming Uttarakhand / Other Himalayan States Scholarship, student will be considered eligible ONLY if he / she is carrying a valid Domicile Certificate in Original at the time of reporting for Counselling / Admission.

**If any student submits Domicile Certificate after the deadline/due date for submission, then the UK Scholarship will be granted from Next Semester/Academic year only, not retrospectively.**

The students admitted under Uttarakhand / Other Himalayan States Scholarship will continue to avail the above scholarship for their entire programme duration.

## **(C) SHRI NAVEEN AGARWAL JI SCHOLARSHIP FOR GIRL STUDENTS**

### **Applicable to: UG Programmes**

Scholarship of 10% on Tuition fee is applicable for Girl students in first year of UG programmes subject to the following conditions:

1. Student has scored 80% & above in X & XII Std **aggregate**\*
2. Scholarship percentage will remain same for all categories of admission.

To continue the above scholarship, the student should maintain a **CGPA of 8.5** and above every year, without any back paper, UFM and Indiscipline case.

**\* Aggregate: Marks of passing criteria subjects of respective Board / Best of minimum required subjects.**

## **(D) SCHOLARSHIP FOR CHILDREN OF DEFENCE PERSONNEL [INDIAN ARMY, INDIAN AIR FORCE, INDIAN NAVY, INDIAN COAST GUARDS, PARAMILITARY FORCES INCLUDING CAPF(AC)]**

### **Applicable to: UG Programmes**

#### **1. Scholarship for Children of Defence personnel (Serving / Retired)**

Scholarship of 5% on Tuition fee is applicable for the Children of Defence personnel in first year of the UG programmes.

For claiming the scholarship, student will be considered eligible ONLY if he/she is carrying a valid Certificate / document as under in original at the time of reporting for Counseling / Admission:

- (i) **In case of serving Defence Personnel –**
  - a. Dependent's card issued to the servicemen / A Certificate issued by the Unit Head / C.O. of the Servicemen
  - b. Aadhaar card of the Serviceman
  - c. Aadhaar card of the student

- (ii) **In case of retired Defence Personnel –**
  - a. Discharge Certificate of the Servicemen
  - b. Aadhaar card of the Serviceman
  - c. Aadhaar card of the student

## **2. Scholarship for Children of Defence personnel (Martyrs Defence Personnel / Gallantry Medals Awardees)**

Scholarship of 5% on Tuition fee is applicable for children of Martyrs Defence personnel in first year of the UG programmes, in addition to point no. (D) 1 as above.

For claiming the scholarship, student will be considered eligible ONLY if he/she is carrying a valid Certificate / documents as under in original at the time of reporting for Counseling / Admission:

- a. Dependent's card issued to the servicemen/A Certificate issued by the Unit Head / C.O. of the Servicemen
- b. Aadhaar card of the father / mother
- c. Certificate of Gallantry Medal Award
- d. Aadhaar card of the student

## **(E) SCHOLARSHIP ON THE BASIS OF PERFORMANCE IN SPORTS**

**Applicable to: UG & PG Programmes**

- a. The scholarship amount will be awarded as per Sports Scholarship policy which is applicable on Tuition Fee only for first year students.
- b. Students of second year onward will be eligible for scholarship subject to participation in International/ National/ State Level sports activities subject to approval from competent authority.
- c. Sports Scholarships shall be over and above other Scholarships.

**Note: Sports Scholarship will be credited in two equal installments in Odd/Even Semester as applicable.**

## **(F) FINANCIAL ASSISTANCE FOR SIBLING(S)**

**Applicable to: UG & PG Programmes**

Scholarship of 5% on Tuition fee of first year is applicable for the siblings of present students / Alumnus on submission of following documents:

- a. University ID card and Aadhaar / Any valid photo ID proof of the siblings bearing the name of the parent (Documentary proof of sibling is to be submitted).
- b. Copy of the Degree Certificate issued to the sibling by DIT / DITU (if applicable)

The above scholarship would only be granted, if the student's sibling is presently studying or has completed his / her studies from DIT / DIT University.

Scholarships for siblings from the same family shall be awarded to both siblings who are taking admissions together.

## **(G) SCHOLARSHIP FOR GRADUATING STUDENTS ON OPTING FOR A HIGHER PROGRAMME AT DIT UNIVERSITY**

### **Applicable to: UG & PG Programmes**

Scholarship of 5% on Tuition fee of first year for the students graduating/graduated with minimum 6 CGPA from DIT University and opting for a higher programme in DIT University with/without year gap on submission of following documents:

- a. University ID Card
- b. Copy of Provisional Certificate issued in the same year / Grade Card (all semesters)

## **(H) SCHOLARSHIP FOR CHILDREN OF SINGLE MOTHER**

### **Applicable to: UG & PG Programmes**

Scholarship of 5% on Tuition fee is applicable for the children of single mother **(whose income is less than 6 Lakhs per annum)** on submission of following documents:

- a. Death Certificate of spouse/ Valid Proof of Divorce issued by Court of Law.
- b. Student has to submit the Certificate of single mother issued by the Competent State / National Government Authority.
- c. Students applying for these scholarships are required to submit copy of their mother's ITR /Form 26AS/income proof issued by Competent Government Authority (in case of non-filing of ITR) of the last two financial years.

To continue the scholarship, the student should maintain a **CGPA of 7.0** and above every year, without any back paper, UFM and Indiscipline case. The student is also required to submit all the requisite documents as mentioned above at serial no. (Ha/Hb/Hc).

## **(I) SCHOLARSHIP FOR DIFFERENTLY ABLED STUDENT**

### **Applicable to: UG & PG Programmes**

Scholarship of 5% on Tuition fee is applicable for the differently abled student on submission of following documents / condition:

The student has to submit the Certificate of handicap issued by the Competent Authority at State / National Government Hospital / Board (as per the guidelines issued by Ministry of Social Justice and Empowerment, Government of India).

To continue the above scholarship, the student should maintain a **CGPA of 7.0** and above every year, without any back paper, UFM and Indiscipline case.

## **(J) SCHOLARSHIP FOR THE ORPHAN STUDENT**

### **Applicable to: UG & PG Programmes**

Scholarship of 5% on Tuition fee is applicable for the Orphan student on submission of following documents / condition:

- a. Certificate from the Women Development & Child Welfare department confirming the orphan status.

- b. An affidavit by the applicant duly notarized given on stamp paper of Rs.10/- undertaking that the applicant is an orphan/destitute.

To continue the above scholarship, the student should maintain a **CGPA of 7.0** and above every year, without any back paper, UFM and Indiscipline case.

## **(K) SCHOLARSHIP POLICY FOR THE CHILDREN OF EMPLOYEES OF THE DIT UNIVERSITY**

### **Applicable to: UG & PG Programmes**

The Scholarship for the children of the Employees of DIT University shall be as under:

- a. 50% waiver in admission fee and 50% waiver on tuition fee over and above the applicable scholarship category of the student.
- b. The Scholarship shall be applicable on all the programmes offered by DIT University.
- c. The Scholarship shall be applicable till the employee is serving the DIT University and shall be withdrawn when the employee leaves DIT University.
- d. The scholarship shall not have a retrospective effect.

The above-mentioned scholarship shall be applicable for the complete duration of the programme under All India / Uttarakhand category in all the programmes.

## **(L) SCHOLARSHIP POLICY FOR THE STUDENTS APPEARED FOR CUET UG-2026 (Details are given in Annexure-1)**

### **Applicable to: UG Programmes**

#### **For First Year:**

Scholarship shall be awarded on the basis of score/ percentage obtained by the candidates at the time of admission and is applicable on the Tuition fee only. Details are given in **Annexure-1**.

## **(M) SCHOLARSHIP POLICY FOR THE STUDENTS ADMITTED UNDER VARIOUS LATERAL ENTRY PROGRAMMES**

### **Applicable to: BTECH and BPHARM Programmes**

Scholarship shall be awarded on the basis of score/percentage obtained by the candidate at the time of admission and will be applicable to the Tuition fee **for the entire duration of the course**. Detailed information is provided in Annexure-1.

**Note: Lateral Entry Scholarship will be in addition to UK/Other Himalayan States Scholarship.**

### **Other terms and conditions for the Scholarships:**

- a. **If a student is eligible for grant of more than one scholarship, the total amount of all scholarships in such cases cannot exceed the total Tuition fee for the Semester.**
- b. In case any candidate falls in Category **(A-Merit Based Scholarship), (B-Uttarakhand/Other Himalayan States Scholarship) & (L-Scholarship**

**Policy for the Students appeared for CUET UG-2026)** the candidate may choose higher of the three options of Scholarship in the year of admission.

In addition to the above he/she will be eligible for Sports Scholarship subject to conditions mentioned in point "a" as above.

- c. If the student belongs to Uttarakhand/Other Himalayan States Category and is entitled for higher scholarship from Category **(A-Merit Based Scholarship), & (L-Scholarship Policy for the Students appeared for CUET UG-2026)** in year of admission **(Refer point "a" above)**, he/she will continue to be eligible for UK/Other Himalayan States domicile rebate for rest of the tenure of the programme, even if student do not meet other criteria.
- d. In case any Girl Student is falling either in Category **(A-Merit Based Scholarship), (B-Uttarakhand/Other Himalayan States Scholarship) & (L-Scholarship Policy for the Students appeared for CUET UG-2026)** and also in Category **(C-Shri Naveen Agarwal Ji Scholarship for Girl Students)**, in such case she will be eligible for Scholarship of Higher of category (A) or (B) or (L) along with additional scholarship of Category **(C-Shri Naveen Agarwal Ji Scholarship for Girl Students)**. In such cases, total amount of all such Scholarships cannot exceed total Tuition Fee for the Semester.
- e. Scholarship Category (C, D, E, F, G, H, I, J & K) are over and above scholarship of Category (A), (B) and (L), as applicable.
- f. Scholarship Category **(H-Scholarship for Children of Single Mother)** and **(I-Scholarship for differently abled Students)** will be as per discretion of the Management based on the documents and other conditions, as applicable.
- g. The students who are eligible for the scholarship/s as per the norms specified by the University should address their application to the Registrar with relevant documents for consideration.
- h. Students completed their schooling from Open School / Part-Time will not be eligible for scholarships category **(A-Merit Based Scholarship) & (L-Scholarship Policy for the Students appeared for CUET UG-2026)**
- i. Improvement marks will also be reckoned for the calculation of eligibility for Scholarship subject to appearance in the same board.
- j. A candidate who appears for additional subject other than taken in the main examination should also appear from the same board of main examination concerned.
- k. Himalayan States Include - Jammu & Kashmir, Ladakh, Uttarakhand, Himachal Pradesh, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura, two districts of Assam namely Dima Hasao and Karbi Anglong, Darjeeling and Kalimpong in West Bengal.
- l. If at any stage, it is found that an applicant has concealed, suppressed, distorted any information / facts which would have rendered him / her not eligible for the admission and / or for benefit of fee / scholarship which has been awarded by the University basis initial documentation, then the admission and / or benefit of fee / scholarship will stand cancelled and all such financial support will be recovered by the University.
- m. In case of any escalation / representation / dispute / discrepancy / clarification, the decision of the Management will be final and binding.
- n. The Management reserves the right to change the Scholarship Policy as per its discretion.

### ELIGIBILITY CRITERIA & DETAILED TABLE FOR SPORTS SCHOLARSHIP (FOR ADMISSION YEAR 2026-27):

#### 1. International Level Participation:

All applicants, who have represented India in International competitions/ sports, namely; Olympic Games, Commonwealth Games, Asian Games and World University Games including Cricket are eligible to award of scholarship under this category against submission of participation Certificate issued by:

- a. Olympic Games by International Olympic Committee (IOC)
- b. World Championship/ World Cup by International Sports Federations (ISF)
- c. Asian Games by Olympic Council of Asia
- d. Asian Championships by International Sports Federations (ISF)
- e. South Asian Games (SAG) by South Asian Sports Council (SASC)
- f. Commonwealth Games by Commonwealth Games Federations (CGF)
- g. Paralympics Games by International Paralympics Committee (IPC)

#### 2. National Level Participation:

All applicants, who have participated in competitions/ sports at National level, as recognized by Sports Authority of India, are eligible to award of scholarship under this category against submission of participation Certificate issued by Sports Authority of India.

Scholarship is applicable for those lists of games, which are included in the Olympic Games, Commonwealth Games, Asian Games, World University Games including cricket.

#### 3. State Level Participation:

All applicants, who have participated in competitions/ sports at State level, as recognized by Sports Authority of State, such as North Zone Inter University Games, Senior State / Junior State / School State Games, are eligible to award of scholarship under this category against submission of participation Certificate issued by Sports Authority of State/ Sports Statutory Regulatory Bodies.

Scholarship is applicable for those lists of games, which are included in the Olympic Games, Commonwealth Games, Asian Games, World University Games including cricket.

### PROCESS TO APPLY

Applicant is required to upload the scan copy of original Certificate of participation in the allotted ERP portal. All the applicants need to bring the original Certificates for verification at the time of admission.

In case, the candidate fails to produce the required Certificate as per the level of participation, he/she will not be considered for the award of scholarship.

Once the process of document verification is complete and approved by the committee, a list of the candidates will be prepared and displayed on the official website of DIT University. Also the information will be shared with the applicant by the committee.
